Receiver D. Ray Strong (“**Receiver**”) filed his Motion for Order Authorizing Receiver to Sell Remaining Assets (“**Sale Motion**”). No objections have been filed to the Sale Motion.

Having considered the Sale Motion and the representation of counsel, the Court finds and orders, as follows:

1. The Sale Motion is granted.
2. The Sale of the estate’s remaining assets (the “**Remaining Assets**”) is in the best

interest of the estate.

3. The Receiver may sell the Remaining Assets at an auction to be held at the Salt Lake City offices of Holland & Hart on or after: (i) fourteen days following entry of this Order and (ii) fourteen days' notice of the date and location of the auction to all creditors.
4. The Receiver is authorized to (i) determine the highest and best offer at the auction, (ii) sell the assets in one or multiple lots, and (iii) implement auction procedures that he deems reasonable to maximize the value of the Remaining Assets.
5. The Remaining Assets will be sold on an "as, is where is" basis and without representations and warranties of any kind, nature, or description.
6. The Remaining Assets will be sold free and clear of liens, claims, and other encumbrances with any such liens, claims and encumbrances attaching to the sale proceeds after payment of approved receivership costs.
